1. General Information

3. Collection and Processing of Personal Data

We only collect personal data when it is necessary and lawful. This may include:

- Email address
- Phone number
- Date of birth (for minors)
- Emergency contact details

Data is collected when you:

- Contact us via website, email or phone
- Register for training or membership
- Sign waivers or agreements
- Participate in classes or events

4. Purpose of Data Processing

Your personal data is processed for the following purposes:

- Managing memberships and training participation
- Communication regarding classes, schedules or events

- Ensuring safety during training
- Legal and contractual obligations
- Billing and administrative purposes

We do not use your data for automated decision-making or profiling.

5. Legal Basis for Processing

Personal data is processed on the basis of:

- Your consent (Art. 6(1)(a) GDPR)
- Contractual necessity (Art. 6(1)(b) GDPR)
- Legal obligations (Art. 6(1)(c) GDPR)
- Legitimate interests (Art. 6(1)(f) GDPR), such as gym administration and safety

6. Data Sharing

Your data will not be shared with third parties unless:

- It is required by law
- It is necessary for contractual obligations
- You have given explicit consent

We do not sell or rent personal data to third parties.

7. Data Storage and Retention

Personal data is stored only for as long as necessary to fulfill the purposes for which it was collected or as required by law.

Once data is no longer required, it will be securely deleted.

8. Data Security

We implement appropriate technical and organizational measures to protect your personal data against unauthorized access, loss or misuse.

9. Your Rights

You have the right to:

- Access your personal data
- Rectify inaccurate or incomplete data
- Request deletion of your data
- Restrict processing
- Object to data processing
- Data portability
- Withdraw consent at any time
